Minutes of the meeting held 9th July 2015. Cllr Woodcock chaired the meeting

Cllr Eaglen proposed that the Minutes be signed as a true and correct record, seconded by Cllr Davis. All in favour.

Declarations of Interest: None

Members of the Public. Four members attended. Two shared concerns over the speed of vehicles through the village and their attempts to obtain further speed restriction signage and convex mirror from NCC.

A member expressed concerns that over signage could spoil the rural aspect of the village.

Pc Bailey

Floor handed over to Pc to give clarification over following points:

When to use 999 or 101- 999 is for emergencies & crime in action incidents, 101 for non- emergency incidents. All calls are graded for response.

The reporting of suspicious vehicles in Crookford wood – Pc response, report incidents using 101, if possible, provide make, model, colour & Registration Number.

Speeding of vehicles through village - Pc response, new speed training courses regarding liveried car are available to Parish Council & members of public – Clerk to discuss with Pc Dave Langmead at South Leverton Ps.

Overweight vehicles – Pc response, overweight vehicles allowed if accessing building sites in village & boundary. If vehicles regularly come through village either contact the companies direct or report to Pc the make, model, Company & Registration Number.

Neighbourhood Crimewatch signs in village – Pc response, Neighbourhood Watch no longer exists it is now rebranded as Neighborhood Alert & persons can register using email address.

Advice on speed restriction signage – Pc handed traffic survey, Pc response, physical interactive signage on a fixed basis & to contact NCC highways, if NCC refuse suggest temporary interactive signage.
