Survey Results

In total 156 surveys were returned, providing a significant number of responses to the questions asked which will help greatly in ascertaining the direction of Treswell and Cottam's Neighbourhood Development Plan.

A breakdown of those responses as a guide to the general themes found is set out below.

Please note that not all respondents completed the whole survey or whole questions.

Comments written anywhere other than in the allocated comments sections have not been collated.





Of 'bungalows', 31 respondents said 'need more', 46 said the current level was 'about right' and 66 respondents said 'none'. For 'low cost / affordable/ starter homes', 51 people said 'need more', 9 said 'about right' while 81 said 'none'. Of 'family housing', 63 respondents said 'need more', 49 said 'about right' and 59 said 'none'. With regard to 'luxury housing', 12 people said 'need more', 49 said 'about right' and 76 said 'none'. About 'rented accommodation', 25 respondents said 'need more', 22 said 'about right' and 85 said 'none'. Of 'sheltered housing, 9 said 'need more', 13 said 'about right', while 109 said 'none'. For 'retirement housing / apartments', 26 respondents said 'need more', 23 said 'about right' and 88 said 'none'. With regard to 'care homes', 6 respondents said 'need more' while 15 said 'about right' and 109 people said 'none'. About 'two storey housing', 41 people said 'need more', 23 said 'none'. With regard to 'care homes', 6 respondents said 'need more' while 15 said 'about right' and 109 people said 'none'. 





For 'shop', 58 people said 'yes', 40 said 'no' and 42 said 'maybe'. In regard to 'improves bus services', 85 respondents said 'yes', while 14 said 'no' and 37 said 'maybe'. Of 'public footpaths', 70 people said 'yes', 42 said 'no' and 24 said 'maybe'. For 'cycle paths', 39 people said 'yes', while 63 said 'no' and 24 said 'maybe'. When asked if they thought changes were needed to certain transport issues, 87 respondents said 'yes' to 'less parking on public footpaths', while 38 said 'no' to this. For 'more public footpaths', 50 respondents said 'yes' and 65 said 'no'. For 'more off road parking', 66 people said 'yes' and 50 said 'no'. About 'the speed of vehicles through Treswell and Cottam', 137 respondents said 'yes' and 11 said 'no'. For 'more cycle paths', 41 respondents said 'yes' while 70 said 'no'. To 'less HGV traffic', 108 people said 'yes' and 34 said 'no'. For 'improved road maintenance', 128 people said 'yes' and 13 said 'no'. Finally, of 'traffic calming', 80 respondents said 'yes' while 56 said 'no'.

- I was under the impression the infrastructure could not sustain further housing development – what changed?
- We moved to Treswell because it is a small, quiet, rural village with plenty of greenery. Any development of new housing should not be permitted since it would spoil the nature and character of this unique village layout.
- Need a solution for slowing traffic down through the village. Speed bumps would be cheap and effective.
- There is too much traffic going through the village and too much rural crime.
- We moved here 40 years ago for a pleasant village setting. Not to be ruined by money making developers.

- I wish the council success in the work it is doing and hope that existing residents will continue to have a say in how the village should develop for future generations.
- Houses built in keeping with village.
- All housing developments should be small and in keeping with the rest of the village.
- We desperately need children's play area and park. Fibre broadband, also the local footpaths (public) are in neglect. Signs are missing and farmers are deliberately painting over them, also allowing young bulls to roam on them. I've complained many times to the county council but nothing has been done.
- The village needs to establish a greater community spirit. Helping older people to access town shopping, prescription collection / Doctor visits etc.
- I would like to see the village grow and prosper in the future.
- The speed of vehicles and amount of vehicles that travel along Town Street through a village location concerns me. Drivers can often be very inconsiderate and seem to have no regard for safety. I strongly believe measures should be taken to reduce the speed of vehicles travelling through the village.

- The roadside drains on Town St need cleaning out they overflow when it rains.
- Our 30mph sign starts way too far into the village at Cottam. It needs moving to slow vehicles before entry to village, and needs slow down signs!

- Love Treswell as it is, so any future building could only be detrimental to the village.
- Fabulous village, a shop or pub would get villagers mixing a bit more (sadly we work anti social hours so rarely get opportunity to visit opening hours for socialising at village hall).

- We moved to the village of Treswell less than 1 year ago for the rural, countryside life for us and our 3 children. As a family we are more than happy with what Treswell has to offer and would be very upset if more residential properties were erected.
- Like it just the way it is, moved to a village because it was a village.
- We moved to the village in 2014, other than speeding traffic and dog kennels noise, being in the village is just what we wanted.
- We need to do something about the speed of traffic passing through the village before somebody dies!!!
- Stop the speed of all traffic through the village before someone gets killed from our village, and stop people from vehicles getting rid of their rubbish in our village.
- Enforcement put in place to ensure existing road traffic laws are respected i.e. speed limits,
 HGV over 18T Do not use Cottam as a through fair to adjacent villages as per the restrictions already in place.
- It must be noted that often with improved local infrastructure can be at the cost of our countryside such as off road parking, road widening and footpaths possibly taken from green verges, hedgerows and fields.
- We do not require any more houses / house developments in the Treswell village. Open to the idea of a shop and supporting local businesses.
- Most people of retirement age are happy with the peace and quiet of village life away from the noise of town and city life. The village hall and a local shop are considered to be the most important aspects to rural life.

- Less HGV traffic, it badly affects the condition of the roads in Cottam. As the village is so small if you encounter a HGV it is very difficult to pass each other in the village.
- We moved to the village as it was a small, rural, quiet village, should it grow maybe we will move on!
- It's OK as it is.
- I like Treswell the way it is, changes are not needed.
- Vehicles need to stop parking and obstructing the bus stop outside the Old Red Lion. It is an official bus stop and should be respected as such.
- Thanks for the survey, gives us all a say in the future of the village.
- I am against any new build project and will voice my concerns. I moved to Treswell because of the character, quaintness, village atmosphere.
- We need fibre optic broadband to allow small businesses to thrive here. Public footpaths need maintaining.
- The village has horses. They have not been considered in anyway. Warning signs, bridle ways, traffic calming all needed. The straight road encourages the idiot drivers, it needs breaking up in some way, perhaps parking bays would slow things down. Drainage is a major issue. The beck cannot cope with extremes of weather. Land owners have cleared it upstream in parts, but nothing has been done in the village to get the water away. More housing and development areas will add to the problem.
- More bridleways for horses and warning signs on roads, traffic calming all needed as there
 has been no consideration given to equestrian activities, this includes green lanes being
 churned up by 4x4's, quad bikes and scramble bikes the main through fare given parking to
 create a 'tidal flow' traffic system which would facilitate calming of speed in the main Town
 street section. Clearing of roadside drains would lessen flood risk, this includes servicing of
 the beck.
- Enforce the 30mph speed limit through the village as speed contributes to accidents. Surface water drains should be maintained by the county council. Blocked drains caused localised flooding when we have heavy downfalls of rain. The district and county councillors should be doing more to protect the villagers and invest in the services.
- Any future developments should be in keeping with the present character of the village. Village needs fibre optic broadband.
- Drainage and broadband must be improved. New developments to be in keeping with rest of village. Speed limits require enforcing.
- Any building development to be in keeping with character of village. Speed limits through villages should be enforced. Drainage would need to be improved. Village needs fibre optic broadband.

- The volume of traffic though Treswell, from the power station and Sundown at certain times of the day, make it inappropriate to develop Treswell for more housing walking along the footpath, reversing out of drives, parking on roads is, at certain times of the day, extremely dangerous.
- More bridleways / byways. Existing bridleways / byways surface maintained. Footpath on pub corner too narrow.
- Roads need better maintenance. Footpaths in a poor state. Paths / bridleways in a poor state. Footpath on pub corner too narrow.
- Families have located here for its rural qualities, yet being accessible to Retford and other centres but rural qualities need to be retained green spaces, open aspects to rear f most homes change needs to be modest and sensitive to the needs of the existing residents.
- I think the area is already impacted by the power station and its traffic implications.
 Recreational space would be good but only if there is more housing. I think a Neighbourhood
 Development Plan could develop a strong powerful force that could implement housing for young people who could then stay in the area and strengthen community spirit or they could campaign for no development and watch the young people move out and the village stagnate.
- Bassetlaw Council to treat residents fairly and not discriminate and favour large developments over the public local good.
- Red lion care home needs more parking availability due to amount of staff / visitors and residents.
- Improve what we have.
- I am in support of sympathetic development within the village.
- High speed of traffic through Treswell is a concern, as is vehicles modified to produce excessive noise.
- No problem with agricultural vehicles such as tractors, but modified off road vehicles which make excessive noise are a concern.
- I am in support of development within the villages.
- Speed of traffic though the village is by far the biggest problem. Lack of highway
 maintenance is creating badly potholed roads. Highway drainage systems are not
 maintained at all, this results in flooding every time it rains heavily. More facilities are
 required for young families.
- If people respected village speed limits there would be no need for traffic calming measures and / or speed cameras. I do think there is room for small scale developments in the villages. The influx of 'new blood' might liven us all up a bit!

- I have lived in Cottam for 28 years. Our views have gradually been reduced by development of farm buildings and extension of neighbouring houses. I would not want any further reduction. A huge concern for me as a business owner is the atrocious broadband (recent speed test = 2.7mbs) I need to be online constantly. There are apparently no plans for high speed broadband in the area this should be addressed urgently.
- Like so many other people in the village I like it the way it is. So I am reluctant to see any major changes.
- We would rather see the village extended rather than in-filled.
- For design of new or converted housing to be 'modern' if desired, and for more opportunity for commercial activity we don't want the village preserved in aspic it needs to maintain the village feel, but it can be up to date development.
