 - c. Mrs C Mckinder – Head teacher Ranby School – The Parish council asked Mrs Mckinder about the problem of parent parking when dropping off and picking up their children from School. Mrs Mckinder stated the school were aware of the situation and had already gone to great lengths to try and calm the situation, including letters home, walking children to school and looking into a school bus. She stated that as only 22% of the pupils were within catchment that many children had to be driven into school due to the distance they lived way from school. Mrs Mckinder went onto say that the Breakfast club and after school club have helped reduce the amount of parents that are parked at any one time, she also asked for any ideas that the Parish Council had as the school was open to any ideas. The Parish Council agreed to look into the traffic calming signs and ask highways to look into speed

bumps, rumble strips and zebra crossings in and around the school. There was also a suggestion of contacting Ranby Prep school to ask if they could utilise some of their land to create a separate access road into the school.
