Fracking – Mr G Fridlington gave a report on the meetings he had attended concerning Tinker Hill – He advised that a community liaison group had been set up which is an independent organisation set up to represent the local community, the group included representatives from various groups and meetings are held every two weeks in case anyone else wished to attend these.
- e. Broadband – Mr A Howard reported that N3 had come across a technical hitch which could mean that a further £7470 will need to be found to get broadband into the village. A Lilley stated that the parish were limited to how much they could give under S137 Monies. It was stated that if the broadband does not go ahead then the Parish council would have to ask for the grant money back.
