76. Apologies for absence.

Apologies received from Mrs. Hill & Mr. Quigley N.C.C.

77. Question time.

There were no members of the public present.

78. Declarations of Interest.

Mr. Pashley declared a personal interest regarding his son's proposed to building a web site for the Parish Council. This matter to be discussed under village matters.

79. Adoption of Minutes

It was proposed by Mrs. Childs & seconded by Mr. Ing that the minutes of the minutes of the meeting. held on Tuesday 12th September 2017 be accepted. All were in agreement.

80. Co-option

Mrs. Lyndis Ing was Co-opted onto the Parish Council and all relevant forms were signed.

81. Matters arising.

Mrs. Taylor gave an update on issues relating to Little Grange Farm, which is still ongoing.

Mrs. Childs suggested that the Parish Council should display a notice on the village notice boards stating anyone who displays advertising material within the village should remove it as soon as possible after the event or the Council will remove it.

This is being done in an effort to keep the village tidy.

82. Village Hall

Mr. Ing suggested that as Christopher Ware from Wren Kitchens had been very helpful regarding refurbishment of the hall kitchen we should purchase a small gift and thank you card for him which will be paid for from the Chairman's fund. All in agreement.

As part of the refurbishing programme the old box unit containing a record player should be disposed of. Mr. Fraser to contact Mrs Sally Palmer to see if she knows who is the owner of these items.

84. Grant Applications

Mr. Fraser informed the meeting that he had submitted an application to I. Gas for their community fund regarding funding for the Village Hall.

85. Highways.

The Chairman informed the meeting that we had applied for and received 5 20kg bags of salt from NCC under their winter assistance programme for Parish Councils.

This salt is not for private use but for use on footpaths and other areas where there may a hazard.

Last winter was not severe so we have 8 bags available for this winter.

Allocation is as follows.

One bag at the entrance of The Coppice. To assist with the entrance to the Coppice.

One bag at The Rowans. To assist exit onto the A638.

One bag at Kymba & Kenya Lodge to assist exit onto the A638.

One Bag at the Village Hall.

Suggestions were requested as to other areas where this salt could used.

The Council has received notification From NCC that they intend to extend the 40 MPH from its existing location on the Torworth end of the village to the north side of Milestone Court.

Also the 50 mph will now be in force from the above location to Torworth.

86. Correspondences

A letter from N.C.C. has requested our winter salt allocation. We have applied for the free 5 bags of salt which has arrived.
