# MINUTES OF THE MEETING HELD ON TUESDAY 13<sup>TH</sup> FEBRUARY 2018

## 157. Apologies for absence.

#### 158. Question time.

There was one member of the public present.

#### 159. Village Hall.

Mr. Fraser informed the meeting that he had made enquiries about the PPL licence for the hall regarding the public use of sound recordings. It is believed to cost £49.00 + vat running from 1<sup>st</sup> April to 31<sup>st</sup> March he will follow this up next month.

An enquiry has been made with regard to hiring the hall for pie making , the Council thought this was an interesting project and perhaps a fee of £50.00 could be acceptable.

Further enquiries to be made.

It is still hoped that a craft evening could be held on Friday 16<sup>th</sup> March 2018.

A new handle has been ordered for the oven at a cost of £12.22 when this arrives we will contact the kitchen fitter to do this work and sort out the flooring between the kitchen & storeroom.

We have received a grant from Mrs. Taylor's Bassetlaw fund, this is to purchase crockery, pots & pans.

Mr. Pashley will make enquires about this purchase.

Mr. Quigley informed the meeting that he could give a grant of £500.00 towards a project.

It was suggested it could go towards updating the hall toilets. Mr. Quigley requested we inform him of the cost of this project.

#### 163. Planning.

We have received a Planning Application from N.C.C. regarding Hanson's proposed quarry at College Farm Barnby Moor.

The Parish Council object to this proposed development for the following reasons.

The site at this time is being used as good quality farm land.

We understand a larger quarry has been given permission at Sturton but has not been developed so why is a smaller quarry being considered for Barnby Moor.

Some residents at College Farm have been informed that workings will be 300 + meters from their properties and should not cause any inconvenience. A resident who lives close to the new proposed entry/exit at the site expressed concern that their garden is 6 meters from this entry and having small children they are worried about pollution from the quarry lorries affecting the children when playing in the garden.

## 164. Highways.

We are still trying to get local funding for the proposed new village signs.

Mr. Pashley expressed concern about NCC moving the existing village sign near Milestone Court.
