#### **1. Apologies for absence.**

#### **2. Question time.**

#### **3. Declaration's of Interest.**

task was to great and we would do the preparations and get a local handyman to complete the task.

Marcus who lives at the Kennels has been approached by Mr. Ing and he is willing to do the redecoration along with a few minor tasks. This could cost between £300.00 and £400.00.

The Council were all in agreement.

## **6. Planning.**

Application No 17/00425/OUT 5 dwellings between The Rowans and Glencoe House.

Chairman Mr. Fraser & the Clerk Mrs Fraser withdrew from the meeting as they had a disclosure of interest in this application.

The Council objected to this application for the following reasons.

- 1) Greenfield farming land should not be used for housing development.
- 2) The existing sewage system is not up to extra housing as it is operating over its capacity.
- 3) The extra vehicles from this development could exceed 30 to 40 for a small village.
