172. Apologies for absence.

173. Question time.

There were 7 members of the public present who attended to voice their opinions about the proposed planning application for a Crematorium in then parish of Babworth & Ranby off Old London Road at Barnby Moor.

A general discussion took place and the overall comments from the public were against the proposal the main reasons being,

- 1) Traffic flow and consequential volume of traffic that this development will incur on Old London Road.
- 2) Junction safety at both the A638 and Old London Road also at the junction of Old London Road and the road to the A1.
- 3) Loss of domestic amenities for the residents at Diggles Lodge.
- 4) History of road traffic accidents at the junction near Diggles Lodge.
- 5) The increase in traffic throughout the village bearing in mind the extra traffic which will be generated with the proposed two quarries and the fracking site on Blyth Road also the opening of the new Spa development in the village.
- 6) The possibility of odours from the site.

174. Declaration's of Interest.

There were no declarations of interest.

175. Adoption of Minutes

It was proposed by Mr. Ing and seconded by Mrs. Childs that the minutes of the meeting held on Tuesday 14th February 2017 be accepted. All in agreement.

176. Matters arising.

We have contacted Wren Gas to replace the tap in the ladies toilet and to have any suggestions for a friendly user timer for the central heating.

To date we have not received a reply.

We should contact another plumber.

We have authorised Jones & Co to research our deeds reference the enquiries we raised, but have not received a reply to date.

We have contacted three grass contractors for quotes for this year.

Two replies have been received.

We requested the following, 7 months April to October2017 depending on weather, one cut of verges and two cuts of playing field per month.

Verges only if we can do the playing field ourselves.

Hoe & Mow.

Verges & playing field £243.12 per month +7 months total for 2017 £1701.84 no vat.

Verges only £81.04 x 7 = £567.28

Homes Groundcare Maintenance.

We can reclaim vat from them.

Verges & playing field £210.00 per month x by 7 = £1470.00

Verges only £132.00 per month x by 7 =£924.00.

Mr. Ing and Mr. Pashley requested that Mr. Sanderson from Hoe & Mow be contacted and to arrange a meeting to discuss the state of our grass verges.

It was suggested we decorate the interior of the Village Hall on Sunday 9th April. Perhaps a free drink be given to volunteers afterwards at the White Horse.

Perhaps local residents could be contacted to seek their help in the project.
