137. Question time.

141. Village Hall

B.D.C. have been informed that we would like the bottle bank but could a litter bin be placed near it for the public to put bottle tops and other rubbish in order to keep the area tidy. B.D.C. will visit to assess the site.

Wren Gas has done the service on the hall boiler.

Mr. Fraser informed the meeting that Wren Gas stated the boiler was adequate for heating the hall but suggested we install more and larger heaters.

Mr. Ing said a cheaper and better solution could be the installation of modern overhead heating. Also he had an electrician calling to see him on Friday and he would get some advice from him.

Mr. Fraser updated the meeting on the proposed Ceilidh which is to be held on Saturday 28th January 2017.

The Bracken Rigg Dance Band have been booked Mr Fraser has sent a personal cheque to the band as a deposit £80.00 the remainder £320.00 can be paid by Parish Council cheque on the evening of the event.

Mrs Hill volunteered to do the posters and tickets for the event.

As the Village Hall still had to have the electrics P.A. Tested it was agreed we should look at purchasing a tester as Mr. Pashley's son is qualified to use the equipment and is willing to carry out this function and may do this job for other Parish Council's.
