## MINUTES OF THE MEETING HELD ON TUESDAY 12 APRIL 2016

### AT BARNBY MOOR VILLAGE HALL 7.30PM

#### **40. Apologies for absence.**

Mrs J. Childs , Mrs Taylor & Mrs A. Fraser.

#### **41. Question time.**

There was one member of the public present Mr T. Derbyshire from Bilby.

#### **42. Declaration's of Interest.**

There were no declarations of interest.

#### **43. Adoption of Minutes**

It was proposed by Mr. Pashley & seconded by Mr Ing that the minutes of the meeting held on Tuesday 8<sup>th</sup> March 2016 be accepted. All were in agreement.

#### **44. Matters arising.**

Mr. Pashley brought up the issue of clearing the footpath of gravel outside Milestone Court.

The path had a clean in January but not completely and should be redone. Mr Pashley has contacted the relevant authority and expressed his dissatisfaction about the work done. He is awaiting a reply from them but as this date he has not received any.

We have contacted Green Mile Trees, Ranby, Sutton and Ranskill Schools about planting a tree and time capsule to celebrate the Queen's birthday. To date we have not received any replies.

It was suggested we should also contact Ranby House School re above.

Time Capsules are priced at the following.

10 litres        £178.00

25 litres        £287.00

All will be plus vat.

This is to be held in abeyance until we have feed back from local schools.

#### **45. Village Hall.**

Mr. Ing still looking into new energy prices for the Village Hall.

Mr. Fraser informed the meeting that we had been successful in obtaining a grant from I. Gas from their Daneshill development £2000.00. This money when we receive it has got to be used within one year.

It was suggested that the community be contacted as to how this grant could be best utilised.

We have received an estimate from DGD construction for full works at the hall, this came to £38310.04.

A general discussion took place and it was decided that we maybe should do the works required in stages.

The Parish Council to pursue estimates re grass cutting.

#### **48. Highways.**

The Pay Back scheme have been in the village and cleaned the footpaths between the south bus stops and the Rowans, we think the rest of the footpaths will be done later, but will check that this will happen.

Mr. Fraser informed the meeting that he had received a print out from the Minister Of Transport re traffic flow for 2015.

This was for H.G.V.s which stated that about half a million vehicles travelled through the village during 2015.

Mr. Ing requested that Notts C.C. be contacted to ascertain what the requirements were to find out what the criteria was regarding speeding.

#### **49. Correspondence.**

An e-mail has been received from Sutton about a celebration of service for Mr. Brian Birkett who is the Tower Captain at Sutton Church.

The service is to be held at 3pm Sunday 10<sup>th</sup> July 2016 with the quest preacher The Bishop of Sherwood The Right Reverend Tony Potter. This to be pass on to residents.

No one from the Parish Council can attend.

The Parish Council has received an e-mail from Mr. John Crane stating the following,

I've just received my council tax bill for the coming year and noticed that Barnby Moor parish council have once again increased their parish precept.

I am not sure if we were the parishioners not consulted about this?

Other questions spring to mind. Apart from why an increase is necessary, what is the increase expenditure being used for?

At a meeting I attended several years ago there was surplus of over £20.000 in the bank, for kitchen refurbishments as I recall, which have yet to be implemented and for what sound reason.

To me , and to the other parishioners at least, an explanation for the increase and of any forthcoming major expenditure should be made.

A reply to Mr Crane was read out and the Parish Council agreed that this was in order with the addition of the following. (**As the Parish Council are a voluntary organisation and do their best for the community it would appreciate any help from the parishioners. Would you be willing to assist community and in what way.**)
