## **MINUTES OF THE MEETING HELD ON MONDAY 2ND NOVEMBER 2015**

#### **259. Apologies for absence.**

#### **260. Question time.**

One member of the public was present.

Mrs Kate Firth the manager of Ye Olde Bell discussed with the council the purchase of a defibrillator between the hotel and the Parish Council for the village. It was agreed that this was a good idea and as the hotel was open 24 hours a day this was the ideal place for it.

The defibrillator would cost about £1000.00 which would be split between both parties but we will try to raise funds to help with the cost. Mrs Firth said she had gone ahead and ordered the item and 6 members of her staff were undergoing training to operate it.

It was also agreed that we should canvass the parishioners with a view to obtaining contributions.
