## **MINUTES OF THE MEETING HELD ON MONDAY 2ND DECEMBER 2015**

#### **273. Apologies for absence.**

Mrs Yates will have to leave the meeting by 8pm she briefed the meeting on the I Gas fracking on Blyth Road.

#### **274. Question time.**

There were no members of the public present.

#### **275. Declaration's of Interest.**

There were no declarations of interest.

#### **276. Adoption of Minutes**

It was proposed by Mrs Palmer & seconded by Mrs Childs that the minutes of the meeting held on Monday 2<sup>nd</sup> November 2015 be accepted. All were in agreement.

#### **277. Co-option.**

Mrs Carolyn Radford of Barnby Moor Hall and Mr Steven Pashley of 1 Milestone Court have agreed to be co-opted onto the Parish Council both were unable to attend this meeting but should be able to attend our next meeting and sign the relevant forms.

#### **278. Matters Arising.**

Mr Fraser has devised a spread sheet in order to do a door to door survey on the proposed Fracking. Also included in the survey is the proposed development of the Quarries and the proposed closure of Sutton Level crossing this should let us know what our parishioners opinions are on the three proposed projects.

### **279. Village Hall**

### **280. Planning.**

The following planning applications were discussed.

15/01517/Ful. Spa Complex at Ye Olde Bell.

15/01421/HSE. Erect front porch extension, renew dormers to front elevation erect two story rear extension including balcony, render front elevation, demolish existing garage and erect new single story garage.

There were no objections to the above planning applications.

At this time P.C.S.O. 8139 Dave Airey joined the meeting and gave a briefing on the police report for the area.

The Parish Council's main concern was again speeding. It was agreed that in the new year Mr Fraser should contact the Department of Transport and request the flow and traffic speeds for 2015 and this information be passed to Sgt Tony Croft,

### **281. Playing field.**

It has been discussed at a previous meeting the purchasing of a gift for Daren from Ye Olde Bell who has been very helpful in repairing damaged play equipment. All were in agreement.

### **282. Highways**

Lamp post No 16 is still not working. We contacted N.C.C. by e-mail on the 2<sup>nd</sup> November 2015 but to date no reply has been received. Mrs Yates will chase this up on behalf of the Council.

### **283. Correspondence.**

The Clerk has e-mailed Oliver Meek at N.C.C. about the Fracking off Blyth Road on behalf of the Council objecting to the project, at this time the main reason would be the increase in H.G.V. traffic which will have to transport water to and from the site.

B.D.C. has informed the Council that as no one had requested an election for the vacancy caused by the demise of Mr Bower we can go ahead and co-opt.

**285. Village matters**

Mr Fraser informed the meeting that he had contacted Just Giving about donations for the defibrillator. It would cost £15.00 a month + vat for them to manage the account. It was agreed that we put this on hold for the time being.

Mrs Taylor gave us an update on the proposed County Boundary Changes, it would mean Barnby Moor moving from Misterton ward to the West Retford ward which would also include Ranby and Babworth.

Mrs Childs raised the matter of the defibrillator. How will people be made aware of the location of the machine.

Mr. Fraser informed the meeting that there was an article in the Retford Times requesting the location of defibrillators in the area, he has contacted the organisation and they were aware of the one at Ye Olde Bell. The plan is that the organisation collate this information and pass it on to the East Midlands Ambulance Service in order that if a call is received by 999 the operator should inform the caller where the nearest defibrillator is located.

We will check with E.M.A.S. to see if this is so.
