

Minutes of the Meeting of the Parish Council Held at the Welbeck Club on Tuesday, 29 November 2016

Present: Councillors: J Cuckson (Acting Chair), C Chambers, S Cuckson, K Dukes, W M Woodcock (Clerk)

It was with shock and deep sadness that Members and the Clerk had learned of the death of Councillor Robin Brown, the Parish Council Chairman, who had passed away very recently on Saturday, 26th November 2016. Councillor Brown had served on the Parish Council since June 2005, becoming the Chairman in July 2008. He had been an active, pro-active and enthusiastic councillor, a widely respected colleague and a friend and he would be greatly missed. Thoughts were with his family.

1. Apologies for absence

Apologies for absence were received from **Councillors M Newton** and **D Wall Resolved** to accept the apologies for absence.

3. Public Forum

There were no members of the public present.

DC Kevin Dukes reported on the following:

- There were plans to develop the neighbouring Whitwell Colliery site, providing an area of woodland around a plateau with a lagoon and leisure area.
- Work on the A60 at the junction for the Dukeries Garden Centre had been put back pending other planned improvements, including a footpath crossing from the Garden Centre and a lowering of the speed limits on the A60. Work would now begin in January.
- The consultation meeting for the Bassetlaw Plan had taken place on the 23rd of November in Lady Margaret Hall. The Plan aimed to deal with settlements in clusters.
- Improved Broadband it had been agreed to use the existing pole at High Holbeck with line of sight to Stable Court, linking in to the Welbeck Estates facility. The next stage was to deliver letters and forms from N3, which DC Dukes had brought along, to each household for information and expressions of interest. DC Dukes agreed to get the forms amended prior to distribution to include a reply facility to Bassetlaw District Council (BDC).

Thanks were extended to DC Dukes for his input.

4. Minutes of the previous meeting

The minutes of the Meeting held on Tuesday, 1 November 2016 were accepted as a true record. The Acting Chairman signed them accordingly.

6. BT Pay Phone/Phone Box in Holbeck

Following BDC's failure to notify the proposal from BT to remove the payphone in Holbeck, as reported at the last meeting, Clerk had had no response from BDC to issues raised. The customer service/liaison from BDC had fallen far short of what might be expected between the two Authorities.

Having been made aware of the concerns raised by the Parish Council and recent problems encountered with BDC, Councillor Dukes in his District Councillor capacity agreed to raise the matter with the Planning Department. He confirmed he was aware of the BT plans to remove the telephone/telephone box and had been in touch with Welbeck Estates. Whilst it seemed unlikely that the payphone could be saved, in view of the lack of use, Welbeck Estates was as keen as the Parish Council to ensure the red telephone box was retained, being an iconic feature of the village, and would undertake to maintain it if the Parish Council adopted it.

The appointed examiner had sent back a list of questions to the Steering Group, which had been responded to. There was nothing further to report at this stage. **Noted**

Approval was sought to purchase this book.

Following CC Greaves visit to the area earlier in the year, the matter of encroaching verges was being looked into. County was also looking at traffic calming/reducing the speed limit on the A60 and reviewing the position regarding the Cycling Club's use of the A60 in the summer months.
