# HOLBECK & WELBECK PARISH COUNCIL

### Minutes of the Meeting of the Parish Council Held at the Welbeck Club on Tuesday, 24 January 2017

#### 1. Apologies for absence

None

#### 2. Declarations of interests

Councillor K Dukes - Item 7

#### 3. Public Forum

There were no members of the public present.

CC John Ogle reported on the following:

- The High Court had ruled that Bassetlaw District Council (BDC) consultation with regard joining the Sheffield City Region under Devolution had not been lawful. This followed a petition signed by over 4,500 constituents against the move to align with Sheffield City.
- Broadband Having completed Contracts 1 & 2, the County Council were panning a 3<sup>rd</sup> phase, funded from monies clawed back from BT. However the location would not be known until the end of February 2017. Considering the position of residents in Holbeck Parish, who were not benefiting from all this investment despite paying the same level of Council Tax to the County, CC Ogle advised as to the Better Broadband Subsidy Scheme.

Thanks were extended to CC Ogle for his input.

In his role as District Councillor (DC) Councillor Kevin Dukes reported on the following:

- Further to the High Court decision as outlined by CC Ogle, any plans to join Sheffield were effectively quashed. The Government was unlikely to actively pursue any further plans for devolution in the foreseeable future given the current demands associated with exiting the European Union.
- The next full Council Meeting for BDC was scheduled for Thursday 26<sup>th</sup> January and the Neighbourhood Plan was up for adoption at that Meeting.
- Welbeck Estates had asked DC Dukes to look into adopting the red telephone box as a Community Asset.

 Improved Broadband – following announcements by BT and the government regarding more money being made available nationally to improve broadband facilities, it appeared Welbeck Estates had decided to withdraw their support for the local N3 scheme. The company delivering the project no longer needed to use the Welbeck facility as a signal could be bounced from the existing pole via the former colliery site to West Burton. The letters and forms from N3 to establish the level of take-up for the scheme in the community had still to be delivered. Cllr Dukes would investigate the scheme referred to by CC Ogle with a view to including some literature with the mailshot.

Thanks were extended to DC Dukes for his input.

#### 4. Minutes of the previous meeting

The minutes of the Meeting held on Tuesday, 29 November 2016 were accepted as a true record. The Vice Chairman signed them accordingly.

#### 6. Declaration of Parish Council vacancy

Following the untimely death of late Councillor Robin Brown, there was a further vacancy on the Parish Council.

#### 7. Budget and Precept 2017/18

Budget proposals for 2017/18 were presented and options discussed.

BDC had further reduced the Concurrent Grant as previously advised. The Tax Base for Holbeck and Welbeck had risen slightly from 123.39 to 123.57. Based on the budget requirements, a precept of £3,429 would represent a slight increase of 1.79% but, due to the increase in Tax Base, would only increase the charge for a Band D property by £0.45.

**Resolved** to issue a precept of £3,429. Proposed: Cllr M Newton Seconded: Cllr C Chambers

#### 8. BT Pay Phone/Phone Box in Holbeck

No apology had been forthcoming from BDC regarding their failure to notify the Parish Council of BT's proposals. Indeed, concerns were compounded by an entirely unacceptable excuse being offered along the lines of their having notified a different Clerk/Parish Council residing at the same address.

As per the report from DC Dukes (Item 3 – Public Forum refers), he had been in contact with BT on behalf of Welbeck Estates regarding adoption of the phone box in Holbeck. Cllr Dukes will contact the Clerk as and when he receives a reply from BT.

#### 9. Neighbourhood Planning

After some heated debate between the Examiner, BDC, Welbeck Estates and the Steering Group, the Plan was finally being presented to BDC for adoption (Item 3 – Public Forum refers) after which it would be subject to a referendum. BDC had been criticised for being too dismissive of the Steering Groups concerns and failing to adequately challenge the Examiner on some issues. **Noted**

#### 11. Financial statement and accounts for payment

Clerk reported that the balance of the Bank Account was currently £7,169.37.

NALC had advised that the Council Tax Referendum Principles have NOT been extended to parish and town councils for 2017/18. Under these principles, county and district councils are required to hold a referendum if they wish to increase their precept above a certain prescribed percentage. There had been concerns that the principles would encompass parish and town councils also but this would not now be the case, at least for the next financial year. This position could change however in future years.
