# Minutes of the Meeting of the Parish Council Held at the Welbeck Club on Tuesday, 24 November 2015

#### 1. Apologies for absence

None

**Resolved** to accept the apologies for absence from the inquorate meeting held on 13 October 2015.

# 3. Public Forum

There were no members of the public present.

DC Kevin Dukes reported on the following:

- Broadband DC Dukes had met with representatives for Welbeck Estates. They were willing to match funding to cover the whole Parish area if the N3 Project from BDC goes ahead. There had also been a meeting with the Nottinghamshire Broadband Trust, with BT as the preferred supplier. The original aim to have 99% coverage by the end of 2017 had now slipped to 96.5% by the end of 2019. 2,500 properties in Bassetlaw District would be without superfast broadband. Although they would not identify these properties, it was considered likely it would include all Parish areas on the Holbeck side of the A60. Coverage for the other (Welbeck) side of the A60 was expected in March 2016. A further option exists for the area not covered - BT can offer a Community Green Box facility, but costs can vary widely based on existing power, length of cable run etc. The area would need to be surveyed to determine costs for which BT require postcodes and telephone numbers. With the green box facility, residents can go with any supplier and the option provides much better speeds than the N3 option.
- Devolution the Sheffield City bid had gone through and BDC were affiliated with that. The D2N2 bid for Derbyshire and Nottinghamshire had stalled as this was probably being widened to include Leicestershire.

Thanks were extended to DC Dukes for his contribution.
