BDC had reduced the Concurrent Grant as previously advised. There would be no contribution from any CTB Support Grant. The Tax Base for Holbeck and Welbeck had fallen slightly from 125.22 to 123.39. Based on the budget requirements, a precept of £3,369 would represent a decrease of 1.04% but, due to the decrease in Tax Base, would leave the charge for a Band D property unchanged at £27.30.
