MINUTES

of the Meeting of the Parish Council held at the Village Hall on Thursday 3 November 2016

1. Apologies

Apologies were received from Cllrs. A Stevenson and J Topliss.

2. Minutes of the meeting held on 29 September 2016.

The minutes of the Parish Council Meeting held on the 29 September 2016 were taken as read and accepted as a true record subject to the addition of Cllr Staniforth in the attendance list. The Chair signed them accordingly.

4. Correspondence

4.1 BDC – Code of Conduct Complaint – The Monitoring Officer had investigated the complaint and found that there is no requirement for an individual councillor to deliver information to any specific location or individual and the matter is now closed - noted.

5. County Councillor's Report

Cllr Ogle reported that the petition to ask for a referendum on whether BDC should join the Sheffield City Region had received 4646 signatures and he had delivered it to Westminster.

6. District Councillor's Report

Cllr Dukes reported that the BDC Plan is now in consultation and that there would be an event held at Lady Margaret Hall, Welbeck on 24 November from 16:00 to 20.00.
