

# **NETHER LANGWITH PARISH COUNCIL**

## **MINUTES**

**of the Meeting of the Parish Council held at the Village Hall  
on Thursday 29 September 2016**

### **1. Apologies**

Apologies were received from Cllrs. L Malkan, G Stainforth, R Stockton, Cty Cllr Ogle and Dist Cllr K Dukes (BDC).

### **2. Minutes of the meeting held on 1 September 2016.**

The minutes of the Parish Council Meeting held on the 1 September 2016 were taken as read and accepted as a true record. The Chair signed them accordingly.

### **3. Matters Arising From the Minutes**

IT was queried whether the Landlord of the Jug and Glass had been asked to remove the tables outside the PH as they was still on the village green.

### **4. Cllr Kevin Greaves Notts cc**

The traffic sign on Main Road was working intermittently. Cllr Greaves said that it was of the older type and they were temperamental but he would get the sign monitored. Other measures such as, a light up 30mph sign and a pedestrian crossing were raised and Cllr Greaves said it seemed appropriate that an officer would arrange to walk around with Cllrs to see the issues. The village signs at the entry and exit and the patchy repairs to Queens walk surface were also raised.

Extension of and improvements to the Robin Hood Line and its services were discussed. Cllr Greaves said that the line was very successful and extension of it was being discussed but costing was a problem.

**12. Village Hall**

Darren Redoubt had been concerned at the refusal of the Council to sign a letter of support for Welbeck's proposals to fund improvements and an extension to the village hall from the betterment derived from a residential development proposed on land to its north. Following a conversation with the Chair he understood the Parish Council's position better and was to send another letter. No letter has been received yet. He seemed anxious to resolve the differences concerning Welbeck's proposals for the village hall but as yet there is no date for another meeting.
