1. Apologies

2. Minutes of the meeting held on 2 July 2015.

3. Matters Arising From the Minutes

The footpath through Cuckney Hay Wood is still blocked with debris from tree cutting and the Clerk agreed to again contact the NCC Footpaths Officer.

The verge at Lime Acres has now been cut by NCC.

- 11.2 There is a problem with speeding traffic on Limes Avenue. The Clerk agreed to inform the police.
