91. Village Hall

The emergency door and rear outside light have been repaired.

92. Co-option.

Mr. Simon Pashley was co-opted onto the Parish Council.

93. Apologies for absence.

94. Question time.

There were 11 members of the public present 7 being electors from the parish.

The following questions were asked by parish electors.

Were the Parish Council against fracking.

The chair replied that after undertaking a survey when the application was submitted the Parish Council objected to the application.

Eviction of protestors.

As this matter has been decided on to evict the protestors within the last 6 months it would not be discussed.

Has the Parish Council done a pole regarding the protestors.

The Chair replied that it had not been done and as a decision had been made to evict the protestors within the last six months there would be no further discussion on this issue.

Do the Parish Council forward all correspondence it receives to the village.

The Chair replied that this would not be practicable but did forward items which it thought would be of interest to villagers.

Can a water tap be installed in the kitchen at a height suitable for filling the water urn.

The Chair replied that this could be done but as it was planned to have the kitchen wall tiled it might be prudent to wait till this was done.

95. Declarations of interest

There were no declarations.

96. Adoption of Minutes.

There were no meetings in September & November.

It was proposed by Mr. S. Pashley and seconded by Mr. Ing that the minutes of the meeting on Thursday 9th October 2018 be approved. All in agreement.

97. Matters arising.

Mr. Ing gave an update on new proposals for village signs and will circulate these to the council

98. Tinkers Lane Copse.

An e-mail had been received from I Gas regarding NCC inspection and complaints & concerns raised since the last inspection.

This has been sent to all residents whose e-mail addresses the council have.

The chairman explained that he was under the impression the minutes from the C. L. G. Were available on the web but this may not be the case. He will chase this up at the next meeting of this group.

99. Planning.

The planning application by Hanson's for the quarry at College Farm was formally withdrawn on the 18th October 2018.

But this has been replaced with a new plan which residents have until the 22nd of December 2018 to respond. Mr. Paulk has circulated a flyer to the village regarding other matters but this included the contact details for replying to the application.

100. Highways.

The matter of new village signs is still ongoing. We have received an e-mail from Bawtry Town Council Clerk regarding their new village signs which has advertising on them, this was forwarded to Mr. Ing for his information.

After a request to Bassetlaw about the Community Infrastructure Levy we have received an e-mail confirming that they were holding £790.74 on behalf of the parish and that two developments were pending.

101. Correspondence.

We have received notification from Mrs. Sally Hill the vice chair that she reluctantly has to resign from the Parish Council due to ill health.

The council are grateful to Mrs. Hill for the contribution she has given to the village and her Yorkshire humour will be sadly missed.

A letter has been received from Bassetlaw regarding the County Council's Unitary Proposals.

The Chairman attended a meeting last week where Steve Brown from Bassetlaw gave a presentation on this subject. The general impression from other Parish Councillors present that they would like to retain Bassetlaw as our unitary authority.

Barnby Moor Parish Council agree with this.
