Minutes of the Meeting of the Parish Council held on 7th November 2018 in Rhodesia Village Hall

There were 8 members of the public present.

Councillor Leadbeater welcomed Mr Gerald Connor and Inspector Neil Bellamy.

The problems around the village were discussed and residents were asked if they had reported the problems, some had although some feared the consequences.

Mr Connor asked for an opinion as residents had said they wanted it to stop, he asked how they would like it to stop as depending on what the village wants to happen will determine the outcome. It was stressed that it is the evidence that is needed and villagers were asked if they were going to co-operate with both Neil's team and Gerald's team. Witness cooperation is needed to bring this to an end or to get other agencies involved. Social media will not solve the issues it just causes more work.

Quad bikes on the playing field were discussed and again Mr Connor stressed that these should be reported there is no use moaning about it this will not solve anything it needs reporting. He explained that if we can identify the culprits we can make appropriate referrals to authorities who may help and if they choose not to accept this ultimately there will be consequences. It was suggested that the youngsters could be offered an interest for example a bike project.

Councillor Pressley asked about liaison meetings and was told they had stopped due to people not attending.

Residents were asked to stop putting comments on Facebook as it could jeopardise what has been discussed. They will investigate, be open and honest and let us know if we can do something. Enquiries will be made into a bike project.

Mr Connor and Inspector Bellamy were thanked for coming.

Councillor Leadbeater reported that Councillor Belton has resigned from the council, the clerk was asked to send a letter of thanks.

2. Declaration of Interest

Councillor Pressley declared an interest in the quarry.

3. To approve the minutes of the meeting held on 12th September 2018

Councillor Samuel proposed the minutes of the meeting held 12th September be approved as a true and correct record, seconded by Councillor Hall.

4. Matters arising from the previous minutes

a) Quarry – Councillor Pressley updated councillors on the meeting about the houses on Mary Street which will provide enough money for the quarry although it will not be available immediately.

b) A1 Housing Office

Nothing further has been heard it is still in the final stage, Councillor Pressley will chase this up tomorrow.

c) Events in Village Hall

Councillor Leadbeater reported that bingo had been suggested and table tennis had been suggested to Councillor Pressley who offered to look into this possibility, Councillors all agreed this should be looked into further.

d) Noticeboard

Councillor Hall showed further details of a noticeboard and councillors agreed it should hold 6 A4 sheets. Councillor Hall will make further enquiries locally regarding a board and take measurements which will be reported back at the next meeting.
