

NETHER LANGWITH PARISH COUNCIL

MINUTES

**of the Meeting of the Parish Council held at the Village Hall
on Thursday 8 November 2018**

Present : Cllr M Middleton in the chair, Cllr P Ray, Cllr G Staniforth, Cllr A Stevenson, Cllr R Stockton and Cllr K Dukes (BDC). 4 members of the public were also present.

1. Apologies

Apologies were received from Cllrs L Malkan and Cllr K Greaves.

2. Minutes of the meeting held on 4 October 2018.

The minutes of the Parish Council Meeting held on the 4 October 2018 were taken as read and accepted as a true record, subject to the deletion of Cllr Stockton from the list of apologies.

The Chair signed them accordingly.

3. Matters Arising From the Minutes

Item 9 - Cllr Stevenson reported that the trees on Main Road have been cut and the kiosk on the village green has been painted by members of the public.

5. County Councillors Report

Cllr Greaves reported was not present.

6. District Councillor's Report.

Cllr K Dukes reported that:

1. Peter Mitchel is no longer employed by Welbeck Estates Co.
2. A1 Housing is now back under control of BDC.
3. BDC has a new website.

7. Accounts for Payment.

8. Grounds Maintenance Contract 2019-2021

The Chair outlined the programme for the ceremony:

5 wreaths would be laid, a horse had been arranged to stand on the village green in the morning, there would be drinks and sandwiches at the village hall.

It was **resolved** that the Clerk inform Mr W Bryan that it was not appropriate for the horse to be on the village green but could stand on the verge opposite the Jug & Glass.

10. Casual Vacancies

(This item was taken at the end of the meeting after the public were excluded).

The Clerk reported that he had been informed by BDC that the required number of electors had not requested an election.

It was **resolved** to co-opt Beverley Plumb and Matthew Evans.

11. Highways and Related Matters

Cllr Stevenson reported that:

1. Tetron HGVs were travelling through the village.
2. She had had a meeting with P Roberts (NCC) regarding available funding and
3. There was a building bag containing what was thought to be asbestos at the rear of the hairdressers. (It was noted that BDC would not collect it as it was on private land).

Cllr Stevenson requested that NCC cut the grass verge on the A632. The Clerk will write to Joanne Horton with the request (with a copy to Cllr Greaves).

12. Planning

18/01340/OUT – new domestic dwelling on land at Welfitt Grove – no observations.

13. Village Hall

Cllr Stevenson requested the hire of the village hall on 5 occasions and requested the use of the village hall F.O.C. for 2 Community Events. This was agreed.

She reported that one of the ladies in the Group had re-hung the curtains.
