

## **BARNBY MOOR PARISH COUNCIL**

### **MINUTES OF THE MEETING HELD ON TUESDAY 12<sup>TH</sup> FEBRUARY 2019**

#### **AT BARNBY MOOR VILLAGE HALL 7.00 pm**

Present Mr. C. Fraser (chair). Mr. M. Ing, Mrs L. Ing & Mrs .J. Childs.

Cllr T. Taylor BDC and Cllr M. Quigley were also in attendance.

#### **120. Village Hall**

Mrs. Childs as volunteered to update all risk assessments for the hall and Parish Council before the annual meetings in May.

#### **121. Co-option.**

Mr. Fraser proposed and Mr. Ing seconded that Dr. Rajan Bhojwani be co-opted onto the Parish Council. Dr. Bhojwani accepted, all in agreement.

The relevant documents were signed.

#### **122. Neighbour Hood Policing Issues.**

The local beat manager had asked if he could attend and give the council an update on local crime issues.

No one from the police attended the meeting.

#### **123. Apologies for absence.**

Apologies were received from Mr. Steve Pashley and Mr. Simon Pashley.

#### **124. Question time.**

One member of the public was present and asked about the situation regarding ownership of Tinkers Lane Copse. The council informed him that at this time the Parish Council were having difficulty proving ownership but were still trying to do this.

Mr. Ing proposed that we re contact Jones & Co to check on charges for them to pursue this matter, as we have a large file on actions taken this could be handed to them which should reduce the fee.

The Parish Council were also asked if they could do something about the corner at Tinkers Lane and the A 634 regarding white lining in the centre of the A 634. Some traffic coming into the village are travelling at speed and there is the possibility of an accident occurring with vehicles travelling out of the village.

The Council will contact NCC regarding this matter and believe there was a fatal road traffic accident at this location some years ago.

### **126. Adoption of Minutes.**

It was proposed by Mrs. Ing and seconded by Mr. Ing that the minutes of the meeting on Thursday 9<sup>th</sup> January 2019 be approved. All were in agreement.

It was suggested we contact the Bell again to see if they can assist with the art work for the signs.

Mrs. Taylor and Mr. Quigley to make further enquiries regarding the problem with the parking and motor trading at Milestone Court.

It has been missed from last month's minutes but the Parish Council has agreed to purchased a lap top for the Parish Clerk to use for all council business up to a cost of £350.00. Mr. Simon Pashley to enquire into this matter.

Mr. Ing to contact a builder regarding the price for constructing a boules court.

Mr. Ing also to check on heaters and wiring for the hall.

### **130. Correspondence.**

We have received an e-mail from Torworth Parish Council enquiring about a sit on mower (1) is our mower it for hire. The council are not keen on this, (2) can Torworth come and see our mower working. The chairman has already spoken to Mr. Helliwell about this and this is not seen as a problem, Torworth has been informed that they are welcome to visit us regarding this matter.

The Clerk has contacted Sovereign Play about a free site visit to the playing field regarding a free quote and 3D display for adult play equipment and a boules court. An agent from this company is attending the playing field at 11am on the 28<sup>th</sup> February 2019.

We have received a quote from N & S Property for this years grass cutting.

£130.00 for verges.

£30.00 for strimming the play area and round the main the field entrance.

£20.00 for cutting the play area.

A total of £180.00 per month.

As the Parish Council can cut the play area this would be £160.00 per month and as it will be done twice per month total cost will be £320.00.

The Parish Council are happy with Mr. Smiths work but would like to ask him if the monthly cost could be reduced.

The council would like to thank her for the offer but we are happy with the way things are.

Mr. Jacob from Grange Farm has volunteered to remove the tree stump as he can make use of the timber. The council thanked him for his offer.
