54. Apologies for absence.

55. Declarations of interest.

There were no declarations.

56. Village Hall.

The Council has been informed of the estimate received from JK Building Services, this is pending at the moment.

Mr Ing has made enquiries regarding our energy supplier the information he received was to stay with our current supplier (Opus) for the time being.

57. Local Policing matters.

No one attended from the police.

58. Question time.

There were no members of the public present.

59. Adoption of minutes of previous meeting.

I was proposed by Mr. Ing and seconded by Mr. Fraser that the minutes of the meeting held Tuesday 11th June 2019 be accepted. All were in agreement.

61. Planning.

62.Highways.

Mr. Fraser was contacted by a parishioner who informed him that there was a fairly large hole on the footpath across from Ye Olde Bell. On investigating the matter this was found to be correct. Mr. Fraser also found a hole in the carriageway outside Grove House. Both of these were reported to NCC and the footpath is in hand also the road problem was rectified the next day.

63. Correspondence.

e-mail received from Ard Battye of I. Gas requesting us to verify if still require the concrete blocks, which we showed an interest in for Tinkers Lane to block the car parking space which the squatters created. The reason for this is to try and stop fly tipping. We will ask Mr. Battye for 4 or 5 of the blocks.

We have received an e-mail from NCC regarding the quarry at College Farm ES/3925. It was thought we had objected to this on line but it seems not, we have until October to respond.

Our main objections at this time are, The number of HGV movements which is estimated at 75 a day (this is in and out of the site) this will affect those dwellings close to the site only if the HGVs abide to travelling north on the A638. If there is a problem going in that direction then the HGVs will have to go through Barnby Moor Village.

Noise & pollution is another concern, again mainly to those living nearby.

The Parish Council are aware that this is a response to College Farm quarry but as we are a small village and to possibly have three quarries within the parish boundary seems to be excessive, considering there are other proposed quarries in the area which have a poorer soil quantity.
