MINUTES OF THE MEETING HELD ON TUESDAY 12TH NOVEMBER 2019

AT 7PM IN BARNBY MOOR VILLAGE HALL.

Present. Mr. C. Fraser (chair), Mr. S. Pashley, Mr. M. Ing, Mrs. L. Ing, Dr. R. Bhojwani, Mrs. J. Childs, Mr. R. Boeuf BDC & Mr. M. Quigley NCC.

3 members of the public were present.

One from Sutton Parish Council, one from Ranskill Parish Council and one from Sutton Neighbourhood Watch.

Mr. Paddy Tipping & Insp Neil Bellamay were also present.

92 Apologies for absence.

No apologies.

93. Declarations of interest.

There were no declarations.

94. Meeting with Mr. Paddy Tipping & Insp. Neil Bellamay.

Standing orders were suspended for this meeting.

All present introduced themselves.

Mr. Tipping started the discussion by talking about crime figures for our area which more or less is similar to last year.

The nature of crime has changed with the need for more armed officers due to the terrorism risk and online fraud, abuse also rape & sexual offences have risen due to them being reported more than

they used to be. The reporting of abuse of youngsters in children homes has also increased.

Nottinghamshire Police would like to have 2.500 police officers, at this time they have 2.025. This year they have recruited 282 officers not all of these were new recruits as 135 were existing PCSO'S who had joined the constabulary as constables.

Both our guests gave an outline on the list of questions supplied by the three Parish Councils.

The manpower for covering our rural area has remained at the same strength and at this time they have an extra officer.

The Chief Constable is committed to having rural officers attending parish meetings but this may only be once or twice a year. Ranskill informed the meeting that the last time they had a police officer at their meeting was December last year.

Availability of speed guns. The meeting was informed that the police still had these available and training can still be undertaken, Barnby Moor will pursue this matter. Ranskill informed the meeting that they had purchased their own gun but this was expensive. Ranskill also stated that they have had very little response from the police after sending information to them, it makes you wonder if after all the time and effort undertaken by volunteers it worthwhile is doing this job. Insp. Bellamay was surprised by this and would check on it and to see how the system could be improved.

The installation of CCTV cameras in Barnby Moor was discussed, this could be done at our own cost and in association with Bassetlaw D.C.

Police manpower should be increased in our area with a few more officers when the new recruitment program comes into effect.

The reason local officers are being deployed in other areas at the weekends is due to the Chief Constable's directive that all officers should be used in this way, but officers are still available to cover East Bassetlaw.

Mr. Tipping left the meeting at 9pm and Standing Orders were reinstated at that time. Insp. Bellamay left shortly afterwards.

95. Village Hall.

Work is continuing in the hall, the gents toilet is nearly completed and the ladies is in progress.

Decorating the hall ceiling is in hand.

We are still awaiting a reply from Lisa Taylor at Bassetlaw regarding our CIL grant.

Mrs. Childs said that the outside lights at the end and side of the hall were not working. Mr. Fraser will contact the builders who may have switched the electrics off at some time.

Mr. Fraser also to contact the builders regarding the light switches to leave them as they are and not as Mr. Fraser suggested.

We have 25 people interested in tickets for the musical event in November.
