Minutes of the Meeting of the Parish Council held in the Education Room at The Harley Gallery on Tuesday, 28 January 2020

1. Apologies for absence

County Councillor (CC) Kevin Greaves had tendered his apologies.

2. Declarations of interests

3. Public Forum

No members of the public were present.

In his capacity as District Councillor, Councillor Kevin Dukes advised on the following:

Draft Local Plan – this had been launched and was now open to consultation. It
includes a new Garden Village with a station and details of the housing
allocation in our area, as per the Neighbourhood Plan. Comments on the Draft
Plan were actively encouraged.

Thanks were extended to DC Dukes for his input.

4. Minutes of the previous meeting

The minutes of the Meeting held on Tuesday, 26 November 2019 were accepted as a true record. The Chairman signed them accordingly.

6. Budget and Precept 2020/2021

Budget proposals for 2020/2021were presented and options discussed. The Concurrent Grant from Bassetlaw District Council (BDC) was again £19.00 The Tax Base for Holbeck and Welbeck had again risen significantly from 138.87 to 145.08, therefore spreading the impact of the precept amongst a wider number. Based on the proposed budget requirements, a precept of £4,158 would represent an increase of 5.94% on last year's precept amount but, due to the increase in Tax Base, would make the charge for a Band D property £28.66, an increase of only 0.56% (actually 16p more).

Resolved to issue a precept of £4,158.

7. Welbeck Estate security and public access

Cllr Chambers had requested this item be placed on the Agenda, in order to highlight considerable concerns regarding the recent actions of security guards on the Estate. It was reported that a resident had been challenged and physically prevented (using a car to block them) from walking around the Estate, despite them having done so previously for many years. Although the Estate is private land and the walks around Welbeck are not rights of way, the matter therefore being outside the jurisdiction of the Council, it is clear these measures are not in keeping with Welbeck's policy to encourage newcomers and visitors alike to the area. Whist it was acknowledged that tensions were heightened following a break-in to the tunnels on Christmas Eve, nevertheless, the reported security actions appear somewhat heavy-handed and Members agreed that Welbeck's communication with residents needs to be much better and clearer. Cllr Dukes agreed to raise the matter and seek clarity on behalf of residents.

NALC had advised that the S137 amount for 2020-2021 is £8.32 per elector.

Year End was fast approaching and it would be necessary to appoint an internal auditor.

12. Street lighting

Cllr Dukes had been unable to contact Thomas Campion for any further update.

Welbeck Estates had engaged a Consultant to look at lighting across the Estate and there were plans to convert all their lighting to use LED bulbs.

Council would need to decide whether to accept the switch brokered by the Utility Supplier or not. Cllr Dukes asked for the last email from the Utility Supplier to be re-sent to him, prior to him discussing matters further with Thomas Campion.

Clerk to re-send the email referred to above to Cllr Dukes.

13. Highway matters

Clerk had contacted Nottinghamshire County Council (NCC) and CC Greaves regarding the bus shelter near the Lady Margaret Hall entrance. NCC had confirmed that repair works had been ordered.

However, attempts to report the potholes on Featherbed Lane had proved difficult as NCC stated they were not responsible for this lane. Cllr Cuckson advised they had always undertaken repairs in the past.

Cllr Cuckson reported problems with a considerable number of potholes on Holbeck Lane also.
