001. Apologies for absence.

009. Correspondence.

Mr. Smith our grass contractor has quoted us the same us the same estimate as last year £300.00 PCM for cutting the verges twice a month also strimming round the children's play area and gate into the playing field. He has offered to spray the weeds on Station Road footpath at no extra cost.

The council were in agreement for Mr. Smith to do this work.

We have sent an e-mail to B.D.C. Asking as our hall is not in use

at this time and government has awarded local authorities extra cash has the rates for the hall been suspended. No reply has been as yet.

We have received an e-mail from Mr. Turner (a resident) asking permission to plant wild flower seeds at his own expense in the playing field and he has also requested that the council could consider not cutting the playing field surrounding the football pitch as this would encourage more wild life to the area.

Mr. Fraser has sent an e-mail to Mr. Turner voicing his personal opinion (not the council's) that he would be most welcome to plant seeds in the area where the trees are growing round the edge of the playing field, behind The Spa and along the right side on entering the field from The Drive.

As far as the grass cutting is concerned we purchased a sit on mower in order to keep control of the grass length as in the past if it was not cut regularly it was very difficult to cut due to the large clumps of cut grass left on the field also we sometimes hire out the whole of the playing field.

The Parish Council endorsed the Chairman's view.
