025. Apologies for absence.

026. Declarations of interest

There were no declarations.

027. Village Hall

It was suggested that the locks on the new cupboards should be replaced as they looked industrial locks.

A discussion took place regarding this and it was decided to leave them as they were.

It was suggested that we install a hand sanitiser in the hall entrance Mr. Ing will forward a link for this item to the clerk in order for this to be ordered.

Due to the council getting its VAT refund Mr Fraser thought it would be a good idea to ask our handyman Mr. Smith to paint both toilet's woodwork & doors white also fit the 4 mirrors which

have been bought plus the new cupboards to be painted in the grey paint purchased by Mr. Ing. All in agreement.

Mr. Fraser suggested that we should obtain 4 sets of door handles to replace the old plastic on the toilets, storeroom and kitchen doors.

This was thought to be a good idea but should wait until the current situation is over and we all can visit the hall.

It was agreed that we should contact our internal auditor Mr. Ingman to clarify what the position is regarding the charity status of the hall as to sending the accounts for the hall to the charity commission. The meeting was informed that separate accounts for the hall only are sent to the commission.

028. Question time.

The Chairman informed the meeting that he had sent an e-mail to all our contacts requesting them to let the council know if there were any issues.

We had one reply regarding the flooding which can occur on the A634 at the junction with Tinkers Lane. This has been brought to the attention of the council before and was passed to NCC/VIA for their attention, and this request has been forwarded to Mr. Quigley the councillor for NCC.

029. Adoption of minutes of the previous meeting.

Mrs Childs proposed and Mr. Ing seconded that the minutes of the meeting held on Tuesday 12th May 2020 be accepted. All in agreement.

030. Matters arising.

We have had some progress with the application for on line banking and the Parish Council Debit card .it is hoped that within the next week or two both should be up and running.

Bassetlaw and NCC are both aware of the problem with the public footpath and the private footpath at the Crematorium and are dealing with it.

Little grange Farm. We should have an update on the 19th June 2020.

Fly tipping. We have had a lot of tipping in NCC lay-by at Sutton Bridge, this is in Sutton Parish but Bassetlaw D.C. And the police have been informed.

We have also had many occasions where tipping has and is happening on Tinkers Lane this has been passed to the police for their information and Bassetlaw D.C. Who promptly attended and removed the rubbish which was mainly garden rubbish.

It was agreed that we contact Mr. Simon Pashley who is responsible for the parish web page to verify the following.

The £60.00 per year maintenance for the village web site, does this fee cover Simon putting items on the web site including items from villagers who want to put something on it. If not what are his fee's for doing this.

If we have a problem with the parish laptop what is his charge per hour to correct it.

Can Simon give us a costing on installing Office 365 as this may help us with sending documents and creating groups on e-mail.

035. Village matters.

Mr. Fraser to chase up village signs. Instead of the original 5 if we have only funds for 2 then we should go ahead with them.

A resident has suggested planting bulbs on the grass verges and asking for donations from the residents. It was agreed that this is a good idea. On the Retford end of the village bulbs could be planted outside the Rose's development and along Station Road. On the Torworth end they could be planted across from the Bell and both sides going up to and beyond Milestone Court.

It was also suggested to inform parishioners that as the footpaths have been cleared anyone who's property fronts onto the paths might want to tidy their area, if they are unable to do this they should contact the Parish Council who will assist them. It is fair to

say that the majority of residents do look after the verges which are owned by Notts County Council.

Barnby Moor has never been a pretty village but with the work carried out by the Parish Council and its parishioner's it is starting to look a lot better than it was.

It was also agreed that Mr. Smith our grass contractor should be asked to give a quote for strimming the nettles across from the Bell Cottages and down the new path towards the crematorium.
