1. Apologies for absence

Apologies for absence were received from **Councillors D Wall and M Newton Resolved** to accept the apologies for absence.

County Councillor (CC) Kevin Greaves had also tendered his apologies.

2. Declarations of interests

3. Public Forum

No members of the public were present.

In his capacity as District Councillor, Councillor Kevin Dukes reported:

- Consultation on the Bassetlaw Plan had ended on 28 January.
- Consultations would begin on the rejuvenation of Worksop town centre.
- The former McDonalds building, which Bassetlaw District Council (BDC) had bought back for educational purposes in conjunction with Nottingham Trent University, was to be used as a training centre for nurses and technology.
- County Council elections were still planned to go ahead in May, although they
 might yet be postponed until September. A bi-election for BDC and a number of
 referendums re Neighbourhood Plans were scheduled to take place
 simultaneously.

Thanks were extended to DC Dukes for his input.

6. Declaration of Parish Council vacancy

Further to the letter of resignation from Councillor Daphne Cooper, referred to at the last meeting, it was necessary to declare a vacancy on the Parish Council. Members reiterated their thanks to Cllr Cooper for her service and extended best wishes to her for the future.

7. Budget and Precept 2021/2022

Budget proposals for 2021/2022 were presented and options discussed.

The Concurrent Grant from Bassetlaw District Council (BDC) remained at £19.00

The Tax Base for Holbeck and Welbeck had again risen from 145.08 to 153.63, further reducing the impact of the precept on individual taxpavers.

Based on the proposed budget requirements, a precept of £4,033 would represent a decrease of 3.01% on last year's precept amount, making the charge for a Band D property £26.25. a decrease of £2.41 (-8.41%).

Resolved to issue a precept of £4,033.

8. Maintenance of street furniture

Further to discussions at the last meeting, the email from Thomas Campion with a quotation for the general maintenance of the various benches had been re-circulated.

It was agreed that accepting the quotation from Welbeck Estates to regularly survey and maintain the street furniture was probably the only option available to the Parish Council at this time,. However, it was agreed that the Council owned Notice Boards should also be included in any arrangement.

Resolved to accept the quotation from Welbeck Estates and instruct them to undertake the maintenance and repair of the street furniture, subject to an amendment to include the two Notice Boards.

Clerk to contact Thomas Campion at Welbeck Estates accordingly.

10. Financial statement and accounts for payment
