1. Apologies for absence

Apologies were received from County Councillor Fielding and Lesley Deamer.

2. Declaration of Interest

4. Matters arising from the previous minutes

a) Vacancy/Co-option

Details from NALC have been circulated saying that current advice is that face to face meetings will have to take place from 7th May, hopefully more will be known at the next meeting.

c) Mower

The clerk is still waiting for the legal papers to complete, Councillor Pressley and the clerk have been looking further into this and an email was received today from Bassetlaw who are also chasing it up.

d) Defibrillator

The clerk has placed the order, councillors asked the clerk to contact the shop to see if it can be delivered there if not Councillor Hall will take delivery.

e) Memorial

Councillor Pressley will ask Councillor Fielding to ring the Chairman to discuss this further, councillors will look at what they want to do.
