LICENSING COMMITTEE

34a Fees and Charges 2022/23

The Committee was asked to review the proposed increase to the present level of fees and charges for Licences for 2022/23.

Cabinet had previously approved the overall scheme of fees and charges for 2022/23 at its meeting on 30th November 2021, however licensing fees were only approved subject to approval by the Licensing Committee.

The Principal Solicitor (Licensing and Regulatory) (PS(LR)) advised that it was a legal requirement to publicly advertise any proposed increases in the fees for Hackney Carriage Vehicles, Private Hire Vehicles and Private Hire Operators in the local press.

Members discussed the possibility of increasing the discount on Hackney Carriage/ Private Hire Vehicles for electric and hybrid vehicles in order to encourage the uptake of environmentally friendly vehicles.

Resolved that the fees and charges for 2022/23 be approved as amended to include an increased discount on Hackney Carriage/ Private Hire Vehicles licences; 50% for fully electric and hydrogen fuel cell vehicles and 25% for hybrid vehicles which meet the green vehicle specification.

36a Application for a Combined Hackney Carriage/ Private Hire Vehicle Drivers Licence and Plate Exemption
