The grounds for the review are based on the licencing objectives of the prevention of crime and disorder, public safety and the protection of children from harm.

Prevention of crime and disorder

A number of non-compliant disposable vapes have been seized on two occasions from Retford Market Limited. Illegal cigarettes were found in a wheelie-bin in the alley access from the shop. These cigarettes have been tested and are believed to be counterfeit.

The premises owner, and licence holder, Mostafa MAHMOODI was issued with a warning letter after the first seizure detailing his responsibilities around the sale of vapes in general and to minors.

Public Safety/ Protection of children from harm

Counterfeit cigarette cigarettes do not contain the Reduced Ignition Propensity Strips designed to extinguish the cigarette if it is set down or not drawn on. This has been an E.U. requirement since 2011. The strip works by reducing oxygen supply to the lit cigarette and are an essential fire prevention device.

There are serious health implications of exposure to illegal vapes. These health implications, especially in young people, have been well documented. This has led to the ban of disposable vapes to protect young people. Testing of illegal vapes showed that they contained twice the safe level of lead, 10 x the safe level of nickel and 7 x the safe levels of chromium. The tests also found that illegal vapes contained 10 x the level of chemicals such as formaldehyde, then those found in legal vapes. (Source-University of Derby).

Manufacturers of vapes have to follow regulations on ingredients, packaging and marketing and all vapes must be registered with the Medicine and Health Care Products Regulatory Agency (MHRA). Most illegal vapes do not go through any kind of testing before being sold in the U.K.

There is an increased fire risk form poor quality vapes, damaged chargers and cables and a fire risk from the unsafe disposal of damaged batteries.

On 6th February 2024, Nottinghamshire County Council Trading Standards received information that Retford Market Ltd was selling illegal tobacco.

On 15th February 2024, 97 non-compliant disposable vapes were seized from Retford Market Ltd. They were on display in the shop and contravened the Tobacco and Related Products Regulations by having tank sizes in excess of the allowed 2ml capacity.

The premises owner and licence holder, Mostafa MAHMOODI was issued with a warning letter detailing his responsibilities around the sale of vapes in general and to minors.

On 4th June 2025, Nottinghamshire County Council Trading Standards received information that Retford Market Ltd was selling illegal cigarettes, hand-rolling tobacco and disposable vapes and had been doing so for six months.

On 1st July 2025, a male and female entered Retford Market Ltd and exited with the male carrying a packet of cigarettes in a blue packet. The male unsealed the cigarettes and took one out to smoke. Cigarette packaging in the UK is governed by the Standardised Packaging of Tobacco Product Regulations and the Tobacco and Related Products Regulations. These regulations state that cigarette and hand-rolling tobacco products can only be sold in olive green packaging and with the requisite labelling. 67 non-compliant disposable vapes were seized from Retford Market Ltd. They were on display in the shop and contravened the existing legislation. Also found in a wheelie-bin in an alleyway accessed from the shop, were 3,800 sticks of illegal cigarettes and 4kg of illegal hand-rolling tobacco.

On 2nd July 2025, Nottinghamshire Police received information that Retford Market Ltd was selling fake tobacco that smelt like petrol and chemicals.
